This response is to your request received via e-mail on 04/5/2021 for access to records under the Georgia Open Records Act (GORA). Specifically, you requested access to records for the following: ***“at least once each year. The dam owner shall file an affidavit with the Director certifying that such gates and other appurtenances are in good repair and working order;”***
